

Disclosure on Liquidity Risk as on 30-June-2023

RBI has issued guidelines on Liquidity Risk Management Framework for Non-Banking Financial Companies including Housing Finance Companies. As per the guidelines, the disclosure on liquidity risk as at June 30, 2023 is as under:

i) Funding Concentration based on significant counterparty
